Church Partnership Program

Details & Requirements

- The student must be enrolled in at least **9 semester credits**
- **The church contributes at least 40%** of tuition charged
- **Denver Seminary contributes 10%** of tuition charged

The Calculation

Use the current tuition rate of \$540/credit to calculate the church's contribution:

$$\begin{aligned} \text{Total Credit Hours} \times \$540 &= \text{Total Tuition} \\ \text{Total Tuition} \times 40\% &= \text{Minimum Church Contribution} \end{aligned}$$

The Process

- **Deadlines** The student must submit a completed Church Partnership Agreement form (enclosed) to the Financial Aid Office by the **financial clearance** deadline (typically 10 days prior to the start of the semester).
- **Seminary Discount** When a student enrolls in the minimum required amount of credits, the student's total tuition is discounted by 10% (e.g. the total tuition bill will only be 90% of the regular tuition cost).
- **Church's Portion** The church will be billed for 40% of the student's total tuition bill (unless the church's check is submitted with the Church Partnership Agreement).
- **Invoice** Once student has completed and returned the Church Partnership Agreement to the Financial Aid Office, the church will receive an invoice from Denver Seminary showing the exact amount due for that semester, based on the number of hours for which the student has registered (unless the check is submitted with the Church Partnership Agreement).
- **Application of Funds** The church's payment will be contributed to the student's tuition account, leaving the student responsible for paying the remaining balance.

NOTE To ensure **financial clearance** the student should pay this amount, enroll in a payment plan, and/or have enough financial aid set before the applicable financial clearance deadline (typically 10 days prior to the semester's start date).

WHEREAS the church acknowledges God’s leading in the life of the student named above, herein after referred to as “the student;” and the church desires to sponsor the student for the purpose of qualifying the student to receive a tuition discount from Denver Seminary; and,
WHEREAS Denver Seminary, a non-profit institution, desires to grant such tuition discount to qualified students.
THE PARTIES hereto do agree to enter into this Church Partnership Agreement, according to the terms and conditions more fully set forth as follows:

- **The student** desires to pursue God’s leading in his/her life by attending Denver Seminary. The student must be accepted into a program, and will enroll in and maintain a minimum of nine (9) semester credit hours. The student must maintain satisfactory academic progress to remain qualified for the discount. The student must notify the church when he/she adds or drops classes after Denver Seminary has billed the church.
- **Denver Seminary** agrees to discount the student’s total tuition costs by ten percent (10%).
- **The church** agrees to participate in the Church Partnership Agreement with the qualified student and Denver Seminary. The church will contribute at least forty percent (40%) of the cost of the student’s tuition to the student’s tuition account each semester when billed by Denver Seminary. The church will provide prayer support and spiritual encouragement to the Denver Seminary student as a participating sponsor church.
